Research

The American College of Dentists inaugurated plans to promote research in dentistry and set apart funds for that purpose at its annual meeting in 1937. [J. Am. Col. Den., 4, 100; Sept. and 256 Dec. 1937.] During the years following plans were carried out resulting in extensive researches within dental schools and to some extent, elsewhere. *Grants* in support of and *awards* for achievement (William John Gies, Grants and Awards) have been provided. In addition to these, *Teaching Fellowships*, *Grants to Research Workers* for travel expense, and *Emergency Funds* for loss through disaster have been established. A standing committee of the International Association for Dental Research will actively co-operate with the College in carrying out these plans.
