# The American College of Dentists Celebrates – **A Century of Service to the Profession**

The year was 1920 and the world was changing at a brisk pace. Having emerged victorious from the First World War and with the ratification of the 19th Amendment giving many women the right to vote- America was awash with "possibility."

American doughboys went "over there" and returned with a postwar peace dividend of possibility and prosperity.

Technological innovations like the telephone and radio irrevocably altered the social lives of Americans. Consumer culture flourished, with ever greater numbers of Americans purchasing automobiles and home ownership was increasingly common. The illusion in the 1920s was of infinite prosperity and opportunity, and the sense that America was entering a new, thoroughly modern era.

During this period of prosperity, the national conscience

was reawakening and challenging old assumptions and insisting upon more from the learned professions. The Flexner report (1910) ushered in an era of sweeping changes in medical education and demanded increasing accountability from institutions of higher learning. These changes in medical education had a profound effect on all healthcare education. The dental community instinc-

# Mentors and Mentees— Defining Relationships, Expectations and Opportunities in the 21st Century

It's a fine line.

I've been mentored. That makes me a mentee. I guess at my age one would think I should be a mentor not a mentee. As a life-long learner, I contend that it is possible to be both.

I recently looked to Wikipedia to get a definition for mentoring. "Mentoring is a learning and development partnership between someone with vast experience and someone who wants to learn." The name, mentor, comes from a character in Homer's *Odyssey*. The Goddess Athena takes on the appearance of Mentor, in order to guide Telemachus.

Words that describe mentors were put forth by two of Edgar Schein's students, Davis and Garrison. These words include cheerleader, coach, confidant, counsellor, guardian, guru, inspiration, master, "opener of doors", "seminal source", "successful leader", and teacher. Mentors are also listeners, communicators,

receivers, analyzers, empathizers and collaborators.

Two weekends ago, I went to the Chicago Midwinter Meeting and walked the floor with my son, Dr. Christopher Stilwill and his dental partner. Both graduated from dental school eight years ago. We looked at various products with which he was familiar and some of which I knew. We learned from each other. He knew more about emerging technologies and I knew more of the tried and true and "pearls' informed by four decades of clinical practice.

I thought back thirty years ago when my senior dental partner suggested we go to the Academy of Operative Dentistry Meeting in Chicago. That was the first of many groups to which he introduced to me. We often talked about new thoughts and techniques that would be useful in each of our hands. He did not tell me what to do or how to practice. He was my mentor. It was always how I thought our relationship was structured. He, however, always asked what I thought and whether we should incorporate these ideas in our practice.

I started thinking these last few years that I have been more of a mentee than a mentor. To this day, as a general dentist, specialists are always helpful in diagnosis and treatment. When I first started



# The American College of Dentists Celebrates — A New Century Comes Into View



The ACD will turn 100 years old on August 20, 2020. The 100th anniversary of the first Convocation will be in 2021 and the 50th anniversary of the **ACD Foundation** will occur in 2022. As you might imagine, much is being planned by your Board for our centennial celebration and we are excited about the prospects. The ACD will approach its second century

with the same enthusiasm and commitment that characterized our founding. The American College of Dentists was founded in 1920 by a group of visionary leaders who saw the need to help shape the future of the profession. Their charge was to create an organization structure designed to promote the growth and development of the dental profession and to respond to the challenges the profession would inevitably face. The mission of the College is to advance excellence in education, ethics and leadership. Integral to the College's core mission is the robust online ethics curriculum which is offered





to the profession at no cost. To date, more than 135,000 individual courses on ethics have been taken. This year alone, 3,326 ethics courses have been engaged by the practicing dental community as well as dental students. Additionally, the College provides ethics handbooks

and ethics wallet cards for students.

As our 2nd century comes into view, we remain committed to our role as the *conscience* of dentistry. Enhanced leadership and education opportunities offered through a variety of American College of Dentists scholarship initiatives will made available to our Fellows.

The Board of Regents (BOR) of the American College of Dentists met for their annual spring

meeting April 6-7, 2018 in Annapolis, Maryland. Key highlights include:

#### **Modern Parliamentary Procedure**

The American College of Dentists has adopted a simplified parliamentary procedure to refresh our approach to our deliberative assembly and simultaneously, we launched our inaugural consent agenda format to be utilized for all future Board meetings. The sole intent was to streamline meeting procedures by collecting routine, non-controversial items into a group whereby all are passed with a single motion and vote. The approach provided our Board more opportunities to discuss emerging trends in our profession.

#### Your College is on the Move!

Plans are well underway to move the Executive Office from 839-J Quince Orchard Boulevard, Gaithersburg, Maryland to 103 North Adams, Rockville, Maryland. The North Adams property is in the West Montgomery Historic District with convenient access to public transportation and a nearby hotel and Conference Center. The move coincides with the centennial celebration and associated events. Clearly, your American College of Dentists is on the move with new opportunities in our next century. In preparation for our planned move, the Executive Office has drafted a proposal to archive our files. The Digital Archiving Project, "preserving our past while preparing for our future," is an organizational imperative. Master of Library Science Program Directors at the University of Maryland have assisted us in creating a

#### Dr. Cecelia L. Dows Ethics Scholarships Update

This year's recipient of the Cecelia L. Dows \$10,000 Scholarship for Graduate Study in Ethics has been awarded to **Alma Clark** (Northern California). Dr. Clark will be pursuing a Master of Science in Health Care Ethics at Creighton University.

In order to increase engagement with the three-hour ethics course at Creighton, the ACD Foundation will now be offering \$2000 scholarships for the short course rather than the \$1000 awards previously given. There will be five awards available in 2019, and applications will be due February 1, along with the applications for the \$10,000 graduate degree award.



Dr. Friedman is active in her hometown of Brookline, Massachusetts, serving on the Council on Aging and as a Town Meeting Member. She is married to Dr. Emanuel Friedman, a urologist, and the parent of three sons—one in Zurich, one in Shanghai, and one in Boston.



Regent, Regency 3—Dr. Carole M. Hanes (Augusta, Georgia) is currently a Professor of Pediatric Dentistry and the Associate Dean for Students, Admissions and Alumni at the Dental College of Georgia at Augusta University. Her professional background includes dental hygiene as well as pe-

diatric dentistry. She has been on the faculty at the DCG for over 31 years, for the last 18 years she has served as the Associate Dean. In this role, her primary focus has been serving as the Chair of the Recruitment and Admissions Committee and as the principal investigator (PI) for four HRSA Workforce grants with the emphasis on community outreach for senior dental students. The students spend 8 weeks off-campus in underserved areas providing dental treatment for children and adults in a variety of clinical settings. Dr. Hanes is the administrator for the Dental Student Code of Conduct and presides over student activities such as the White Coat

#### Why and how was I selected?

Fellows of the College are selected for their leadership and clear ability to further the mission of the College, which is to advance excellence, ethics, professionalism, and leadership in the dental profession. The College maintains an independent standing committee for thorough vetting of nominees, who are then sent to the Board of Regents for approval.

- Why does it cost \$650 to be inducted into the ACD?
- The induction fee covers the expense of nominees' attendance at the Annual Meeting and Convocation. Specifically, it includes:
- The cap and gown rental for Convocation
- Two seats at our black tie-optional gala
- One seat at our luncheon
- Attendance at the Meet & Greet welcome reception
- The 10-karat gold membership pin and certificate
- C.E. hours accredited through the Academy of General Dentistry

Most years, the actual cost per nominee exceeds the fee. In addition to the actual meals, the luncheon and dinner dance include entertainment, and wine is served with dinner. The Meet & Greet is a great time to meet other Fellows, and enjoy light appetizers and a cash bar. Our two day meeting is a true celebration of our new Fellows, and of the Fellowship as a whole. Our Annual Meeting and Convocation is well-known for its distinctive speakers and fun social events.

# What can I expect from the Convocation ceremony?

Using many of the ceremonial procedures instituted by the Founders of the College at the first Convocation in 1921, the Convocation ceremony is steeped in tradition. We also engage top-notch speakers who relay current thinking, practice, and research on ethics and leadership, such as this year's speaker, Major General Rob Tempel, a Fellow who is serving as Commanding General of the U.S. Army Regional Health Command – Central (Provisional) and as the 27th Chief of the U.S. Army Dental Corps. Participants wear traditional academic regalia, and special awardees are recognized. Guests are welcome to attend free of charge. Generally, the Convocation lasts two hours. It is a time where we connect with our history while embracing the future.

#### May I bring my family?

Yes, please do! You may purchase extra seats for the luncheon and dinner dance, but the Convocation of New Fellows is free and open to all. You are also welcome to bring a guest at no charge to our C.E. presentations, most of which center on leadership and ethics and can be applied across professions.

#### What does the ACD do?

The College focuses on projects that fulfill our mission of "advancing excellence, ethics, professionalism, and leadership in dentistry." We provide ethics and leadership learning materials through the distribution of educational materials to dental schools, and a robust on-line C.E. program. We also fund scholarships for advanced learning in ethics. 

tively understood the need to address these challenges head on.

Four dental luminaries meeting at the Iowa State Dental Association Meeting, May4-6, 1920, conceived of an organization that would help shape the profession of dentistry by imbuing the highest ideals of public service. The organization that they envisioned would

become the American College of Dentists (ACD). The College was officially founded on August 20, 1920 at the Copley-Plaza Hotel in Boston, Massachusetts. Twenty-Three American dental luminaries were invited to participate in the inaugural event and fourteen of the invitees were able to attend in person. The nine individuals who were unable to attend proffered letters of support and encouragement. As explicitly stated in the bylaws the purpose of the College was "to elevate the standards of dentistry, to encourage advanced study and confer Fellowships to those who have done the meritorious work."The first convocation ceremony was held in 1921 and for every subsequent year since that time except for the interval from 1942-1946 when the Annual Convocation was suspended due to America's involvement in World War II.

From the outset, the College was true to its mission and actively participated in the landmark Gies survey (1926) of dental education for the Carnegie Foundation.

For more than 100 years, the College has been at the vanguard of educational reform and the integration of research in the dental school curriculum. We have judiciously compiled the dental literature and

set rigorous standards for journalism. Each decade brought unique challenges to the dental profession and the College routinely provided the leadership to address those challenges. As we approach our centennial celebration, we will have a unique opportunity to reflect on a century of service to the profession. Our next century will have its challenges and, in response to those issues, the American College of Dentists is poised to create new opportunities in education, leadership and professionalism. The College's laudable history is a clear indication that we have the commitment as well as the capacity to forge new directions to actively engage the challenges that are on the horizon as we endeavor to advance excellence in ethics, education and leadership for successive generations of practitioners privileged to serve the public as dentists.

With the increase in online dues payments, the College will save thousands of dollars each year by ending the third-party check processing arrangement and handling the payments in the office.

Dr. Dale Redig hired Dave and Dr. Dugoni promoted him to academic dean to help build a culture of humanism at Dugoni-Pacific, where everyone is treated with respect. He introduced competency-based education, now the Commission on Dental Accreditation standard for all schools. In 1998, Dugoni-Pacific participated in the Malcom Baldrige National Quality Award process, becoming only one of seven educational programs in the United States to reach the consensus among universities, magnet charter schools, and elite performing arts or science high schools in the country. The basis for this prestigious recognition was a decade-long program of continuous process improvement initiatives in all aspects of the educational program. According to Dean Nader Nadershahi, "this is the fourth Gies Award going to the Dugoni-Pacific School of Dentistry. William Gies was not a dentist, but he left his mark on the profession. Dave Chambers continues in that tradition of humanism, comprehensive patient care, competencies, continuous process improvement, ethics, and journalism."

The American College of Dentists is particularly proud of this worthy recognition for our editor and esteemed colleague. Dr. Patricia Blanton reminds us "Dr. Chambers is a prolific researcher and author. Dave has published more than 600 papers, including 65 in the Journal of Dental Education. He is in his twenty-fifth year as editor for the College, and our journal explores emerging issues facing the profession without being prescriptive. From my perspective, there is no other journal like it in dentistry. It forces the reader to challenge the *status* quo and for that, I am so very grateful. More than most, Dave personifies the mission of the American College of Dentists by advancing excellence in education, ethics and leadership." In 2011, the American College of Dentists received the ADEA Gies Award for Achievement at a Public or Private Partner and Dr. Chambers' deliberate efforts to develop and deploy an ethics online curriculum were foundational to that recognition.

He understands the study of ethics in a way that eludes most people."

Dr. Chambers was asked to give a few remarks at the event and he did not disappoint. He told the assembled guests that,"the last job that William John Gies held was that of Editor of the Journal of the American College of Dentists," and that he was delighted to follow in his footsteps. In his 1937 remarks, Dr. Gies stressed the fact that he was a layman and not a dentist. He said, "I was merely arousing a vigorous professional spirit that had been only dormant in dentistry." Subsequently, Dave thanked his wife, the beloved Jean Hopeman, for her unconditional support and guidance. From where you sit, you see a single individual who has been helping others on their journeys for fifty years. From where I stand, I see a room full of talented and caring professionals who are the best hope we have for improving oral health in America. I am honored to be among you."

An ethical dimension in the care environment is present each and every time an oral health provider interacts with a patient. There is never a situation when the ethical dimension does not exist. Being willing and able to recognize ethical issues is the first step in the process of managing them. The American College of Dentists has partnered with Indiana University School of Dentistry to produce an extended series of video case scenarios. This session will present some of these scenarios to stimulate discussion about common ethical issues in the care of dental patients. A model for decision-making considering the ethical dimension of care will be presented and used during discussion. The video scenarios are currently available for use by practitioners and schools. with root canals and extractions, I got many encouraging words to try to do the procedures myself. Over the years, I have done some more complex procedures and have referred others. I can still hear the "pearls" given to me by colleagues. I still seek those "pearls" today in conversation and meetings as a learning mentee.

It is interesting to me that historically, I got these ideas and "pearls" from older and contemporary dentists who wanted me to succeed. Now I notice more and more that I get them from those much younger than myself. I welcome them and realize that mentoring is not defined by chronology. No single generation has the monopoly on good ideas and "better" is almost always possible.

Each fall I get a chance to speak with SPEA (Student Professional Ethics Association) leaders. Conversations on what they study and the technology that they are using in the schools make me feel as though I have a new chapter as a mentee. They have a set of fresh eyes on the profession. Yes, I am still a mentor to them but they might be surprised to know that I am actively listening to their ideas and thoughts.

So in my mind, the line is blurred between who is the mentor and who is the mentee. It is all about your attitude as a lifelong learner. I try to guide others with knowledge that might help them. I am always trying to listen to what others have to say. As Prime Minister Benjamin Disraeli famously opined "The greatest good you can do for another is not just to share your riches but to reveal to him his own."

So, actively enhance your communication and socialization skills. Cherish those who are mentors to you. Please make every effort to befriend several individuals that you can mentor. They have their own unique set of skills that can be engaged to mentor you if you are willing to listen. I am still being mentored. I anticipate this will continue all my life. It's a fine line and titratable to effect. My expressed plan is to mentor aggressively and be mentored seamlessly.

# American College of Dentists Salutes Dr. John E. Regan of the Indiana Section and the Indiana Dental Association for Championing the Dr. Otto U. King Commemorative Marker

Dr. John E. Regan, a long time Fellow of the College has been collaborating with the Huntington County Historical Society and Museum to place a Historical Marker in Huntington to honor one of the founding fathers of the American College of Dentists — Dr. Otto U. King. The American College of Dentists was founded in 1920 by dental leaders, including officers of the American Dental Association (then called the National Dental Association) President John V.

Conzett, President-elect H. Edmund Friesell, General Secretary Otto U. King, and President of the National Association of Dental Faculties (precursor of American Dental Education Association), Arthur D. Black III. Dr. O.U. King was instrumental in the establishment of the College and the drafting of the bylaws at the inaugural meeting at Copley Plaza Hotel in Boston, Massachusetts on August 20, 1920.

Throughout his long and distinguished career, Dr. King would serve many roles in organized dentistry and at the state and national level. According to The Journal of the American Dental Association (JADA), Dr. King was its first editor, a post he held from 1913 until 1925. As Editor, he founded JADA in November of 1913. He was also elected the First Executive Secretary, a post that was forerunner to today's Executive Director, in

1913. He also served with distinction as the IDA President in 1914-15 and he did all of this while maintaining a private dental practice in Huntington.

According to Dr. Regan, "Dr. King enhanced the prestige of the profession and every practicing dentist. We should be honored to know those outside the profession recognize his significant contributions to society. We can also be justly

proud that a dentist, and thereby the contributions dentists make, are being recognized."

Huntington's local Historical Society agrees. They recently approved construction of a historical marker to be placed at the site of Dr. King's former dental practice. The move has the support of the Mayor of Huntington, as well as the Indiana Historical Bureau. The event is scheduled for June 20, 2018 at 11:30 a.m. at the site of Dr. King's last dental practice, 322 North Jefferson Street, Huntington, Indiana. A luncheon at Huntington University will be hosted by the Huntington County Historical Society immediately following the dedication. Please RSVP to Dr. Regan so your presence may be recognized. 

**Reuben Warren** (Georgia) was recently a featured panelist at the 7th Annual Public Health Ethics Intensive: Ethics Across Generations at Tuskegee University. Dr. Warren is currently the director of the National Center for Bioethics in Research and Health Care and Professor of Bioethics at Tuskegee. He also presided over the Commemoration of the U.S. Presidential Apology for the U.S. Public Health Service Syphilis Study at Tuskegee, held directly after the Ethics Intensive.

Honorary Fellow **David T. Ozar**, Fellow **Donald E. Patthoff**, **Jr.**, and **David J. Sokol** have recently published the third edition of *Dental Ethics at Chairside*:

Professional Obligations and Practical Applications in collaboration with Georgetown University Press. Originally published in 1994, Dental Ethics at Chairside has served as an invaluable resource for tens of thousands of dentists and dentistry students, and this third edition of the gold standard is thoroughly revised and updated. The book includes fourteen realistic



cases and commentary about dilemmas in dentistry, as well as online resources for further research and study.

#### **Sacred Activism**

There is Oakland and there is East Oakland. There is East Oakland and there is deep East Oakland. It is the section of the city where the socioeconomic disparities are the highest. The child poverty rates are above 50 percent. Deep East Oakland's strength is the resource-



fulness of agencies such as Eastmont Wellness Center (EWC) that have located there to uplift the community.

University of California San Francisco (UCSF) partners with EWC. Dental students go to EWC to provide preventive oral health and restorative



care to pediatric patients. These patients differ from most of the patients they treat on campus. They struggle to implement the healthful practices recommended by the students. Many families struggle with meeting survival needs.

I have found that it is insightful for students to go out into the neighborhoods where our EWC families live. They accompany me to meetings where they encounter people who sit on all sides of a social issue. They gain

insight into how community activists address social, structural, economic, and social factors that perpetuate poverty and affect population health.

Students have cathartic moments. They think they know what the community needs. But I insist on cultural humility. For example, students conducted a Community Listening Session. Everyone gained insight from the community residents into the barriers to dental care access. Dental student Jessica Baisley took initiative. She is now tackling access barriers as an Albert Schweitzer Fellow. Her project is linking dental services at EWC to the local middle school have ease of access to dental care.

Dental student Tsegazeab Gessese accompanied me to a meeting about the 30 million word gap at age 3 between affluent and low-income children. The organization offered grants to hold community events educating families about the word gap and motivating them to read, sing and talk to their infants and toddlers. EWC secured a grant and Tsegazeab galvanized dental students to host social events designed to mobilize families to do everything they can to close the word gap.

I take students to a homeless shelter to serve meals. They also learn firsthand how homelessness and food insecurity impact seeking dental care. We can't meet the homeless' long-term needs but a hot meal and oral hygiene kits meet immediate needs.

Under my supervision, students screen the community residents at health fairs. They apply fluoride varnish

and make dental referrals to EWC as a dental home. The students observe that health fairs are more than health screenings. They also meet socioeconomic needs.

Deep East Oakland is a laboratory of sorts for students to examine the influences of social determinants of health on health status. The students and I extend the reach of Eastmont Wellness Center beyond the clinic doors through our volunteerism. We understand the impact of addressing the social determinants of health in ways not possible solely during oral health care visits. Our volunteerism helps inform how we provide patient care. Call us "sacred activists"—wise and passionate "movers and shakers" inside and outside the dental clinic.
